Biography of Mr. Patrick Kirwan:



Kirwan is the Director of the Trade Promotion Coordinating Committee Secretariat at the U.S. Department of Commerce. In this capacity, he coordinates a network of 20 government agencies to improve federal trade promotion and finance programs to increase U.S. exports. He has focused specifically on developing commercial strategies for key markets and improving federal/state cooperation on export promotion. Biography of Gaston Fernandez:



Gastón Fernández is the Head of the Regulatory Affairs Division from the Undersecretariat of International Economic Affairs within Chile's Ministry of Foreign Affairs. Since the beginning of 2019, he has served as the facilitator for the Chile Consensus Framework. His portfolio leads negotiations and administration of trade policies at the bilateral and multilateral level. Prior to his his current assignment, Mr. Fernández oversaw the Department of the Organization for Economic Cooperation and Development (OECD), responsible for representing the Trade and

Investment Committee, the inter-ministerial coordination, and as the national point of contact of the OECD Guidelines for Multinational Enterprises, and its implementation in Chile. Mr. Fernández has extensive experience in management positions, both in the private and public sectors, particularly in the negotiation of trade agreements between Chile and Asia, Latin and Central America, and the European Union, where he was responsible for implementing and administering treaties. Mr. Fernández has represented Chile at international multilateral organization related to trade, such as the World Trade Organization (WTO), the World Customs Organization (WCO), and the Asia Pacific Economic Cooperation Forum (APEC), the Southern Common Market (MERCOSUR), the Pacific Alliance (PA), and the Latin-American Integration Association (ALADI). He also served as a consultant for the Inter-American Development Bank in Washington and the WTO. 10:45-11:10: APEC VISIONARIES: THE IMPLICATIONS OF TECHNOLOGICAL DISRUPTION ON ETHICAL BUSINES CONDUCT IN THE APEC REGION (Presentation 10:45-11:00 / Q&A 11:00-11:10)

<u>Description</u>: When the APEC Principles where launched in 2011, few predicted that the region would realize near universal adoption in codes of ethics by medical device and biopharmaceutical industry associations representing over 18,000 companies. Most would not have predicted that nine APEC economies would launch comprehensive, consensus-based agreements bringing together nearly 150 parties from across health systems. With rapid technological advancement and international harmonization confronting these two sectors and society as a whole, Dr. Julien Durand will offer insights into what this APEC initiative should prepare to confront over the coming years. He will also provide a glimpse into what the key achievements, challenges, and changes could be in ethical business conduct by 2030, offering a perspective on health systems and implications for developing economies. **Time is allotted for questions and answers.**

Dr. Julien Durand is a globally recognized expert focusing on the future of healthcare. He has a dual expertise in (1) advanced health technologies and frontier technologies; and (2) ethics, compliance, regulation and governance of these disruptive technologies. He holds a Ph.D. in Engineering specialized in exponential technologies (space, artificial intelligence, blockchain, biotech, 3D printing, Internet of Things, virtual reality and robotics), a J.D. in technology law and an MBA. member of numerous global commissions and expert groups on governance and regulation of advanced technologies.

Both the APEC Kuala Lumpur Principles and the APEC Mexico City Principles contain substantial guidance on this topic, which has subsequently been implemented across industry association codes of ethics. As the region looks ahead, Dr. Jeff Blackmer will offer perspectives on remaining challenges, and what opportunities exist to encourage leaders in industry and the healthcare professional community to strengthen cooperation as well as to better align incentives and target outcomes. Dr. Jeff Blackmer serves as the Vice President of International Health at the Canadian Medical Association (CMA). Dr. Blackmer completed his medical training at Western University and his residency program in Physical Medicine and Rehabilitation at the University of Saskatchewan. He also holds a Master's degree in medical ethics from the University of Toronto and is currently pursuing his Global

Executive MBA at INSEAD University in France. Dr. Blackmer regularly serves as a spokesperson on leading health issues and appears frequently in Global media. He contributes to international health by serving as

He also serves on the Board of Directors of the City Cancer Challenge (CCan), an initiative aiming to improve cancer care in major cities in low- and middle-

income economies. Furthermore, he is Chair of the Board of the cross-sectoral AMR Industry Alliance, a group committed to tackling the threat of antimicrobial resistance, which includes more than 100 companies and associations representing Rx pharma, generics, biotech, and diagnostics. Prior to joining IFPMA he was Secretary General of Interpharma, the association of pharmaceutical research companies in Switzerland, and for many years was a member of the Board and Chair of a key committee of the European Federation of Pharmaceutical Industries and Associations. Prior to his appointment with Interpharma, Thomas Cueni had a career as a journalist, inter alia as London correspondent for the "Basler Zeitung" and "Der Bund", and he served as a Swiss career diplomat with postings in Paris (OECD) and Vienna (IAEA, UNIDO). He studied at the University of Basle, the London School of Economics, and the Geneva Graduate Institute for International Studies, and has Master degrees in economics (University of Basel) and politics (London School of Economics, LSE).

Faye introduced the Code of Practice for New Zealand's medical technology industry in 2005 and has since served as an international leader in strengthen ethical business practices.

Faye was a member of the Asia Pacific Economic Cooperation (APEC) Code of Business Ethics for Medical Devices Expert Working Group that developed the 2011 KL Principles. In the 2018 Queen's Birthday Honours, Faye was appointed Companion of the New Zealand Order of Merit (CNZM) for her services to the medical technology sector. Faye is a Registered Nurse with a business qualification from the University of Auckland Business School. Faye is a Trustee of the University of Auckland, School of Medicine Foundation and a member of the University's MedTech Centre of Research Excellence Governing Board. Faye is a Board member on two Government Crown Entities; NZ Artificial Limb Board and NZ Standards Approval Board. Faye is also a deputy Chair of the NZ Heart Foundation and Chair of the Heart Health Trust.

Sabrina Chan is Senior Executive Director of the Hong Kong Association of the Pharmaceutical Industry (HKAPI) and has been an integral expert in supporting code of ethics development within the *Business Ethics for APEC SMEs Initiative* since 2012.
